# Completed Carbon Reduction Initiatives

- ☑ The organisation achieved Green Small Business Certification in July 2023, having developed an environmental policy and comprehensive action plan addressing all of the significant environmental impacts of the business
- We prioritise the use of local speakers at our events, to reduce travel and transportation distances.
- Business travel has been reduced through use of video-conferencing.

#### Planned Carbon Reduction Initiatives

Our environmental action plan commits us to the implementation of further measures which we anticipate will reduce the carbon intensity of the business, such as:

- Ensuring that environmental aspects are considered in any future decisions about business premises.
- ☑ Ensuring environmentally responsible purchasing.
- Exploring ways of incorporating environmental considerations into the subjects of the research and engagement activities we deliver.
- Providing our staff with information on environmentally responsible behaviour whilst working remotely and facilitating good practice.
